Payment Due as Agreed: Payment for services rendered by Arizona Pilot Car Service is due as outlined in payment terms fields above.

Late Payment and Interest: If payment is not received in full at the time-of-service completion, a late fee will be applied.

An interest rate of **5%** will accrue on any outstanding balances **every 10 days** until the balance is paid in full. The customer acknowledges and agrees to the application of interest on overdue balances as described above.

Invoice and Charges: All charges will be itemized and communicated clearly in the invoice provided upon completion of the job. Invoice will include the signed rate confirmation agreement and trip sheet attached.

Non-Payment and Collection Actions: If payment is not received within 45 days of service completion, Arizona Pilot Car Service reserves the right to pursue collection actions, which will include any additional fees and legal costs related to the collection of the debt and UCC filings.

Governing Law: This agreement shall be governed by the laws of Maricopa County in the state of Arizona.

By engaging the services of Arizona Pilot Car Service, the customer agrees to the terms outlined above and acknowledges the payment, and late fee policies.
